 - Partner with the city to vitalize lots with art
 - Can do, just need to get city approval for lot usage
 - Can reach out to Bloomberg for potential funding
 - Public commons... once you remediate spaces need to do something
 - Artists are looking for opportunities to learning through hands on engagement on projects
 - Projects meant to degrade into the environment over time as an ephemeral space
 - Alternative: adopt a lot system
 - Talk to the city
 - Examples of other cities leasing vacant lots to artists groups

 - Sign campaigns? Need to explain what the situation is and what the
 - Who is this document for?
 - Community groups
 - a. Need more institutional involvement
 - b. Groups like Camden Fireworks
 - Now there is the "My Camden NJ" app
