- Camden for Clean Air: submitted a letter back in late December air to DEP with concerns about process of air monitoring

 - Not in the realm of the air permitting (Danny)... office of environmental justice
 - The <u>NJDEP OPPN</u> office in charge of this
 - Can they hold a meeting to describe what rule this is and how it came to be?
 - On September 15th, CCI stakeholders and NJDEP met to dive into this topic broadly and not specific to the questions in the letter

 - EJ meetings:
 - Conducted privately by the facility
 - DEP listens in
 - Comments are passed to DEP to make sure they adequately address the issues
 - Driven by <u>EJ rule of NJ</u> (new in 2022)
 - Mike Ewell of Camden for clean air wants DEP response in writing
 - Mike received response on September 15th via letter in email

- a. NJDEP Air Quality/ Odor Report:
 - No citizen odor or smoke complaints were received by the NJDEP in Camden City since the last meeting on July 10th
 - Camden Waterfront South Surveillance conducted 4 times with no actionable observations.
- b. NJDEP Permit updates
 - Both pending permits for piles:
 - Camden Iron and Metal: Pine St. Delaware pier site
 - a. A few permits pending reviews
 - i. Shredder
 - ii. Piles movement
 - b. Once there is a draft permit available, it will be shared with the group
 - EMR: front and Atlantic Ave.
 - Have to wait until EJ process is completed to move forward with permitting process
 - GP Gypsum permit
 - Nothing new
 - Non-liquid waste permit for Covanta
 - Nothing new
 - Todd: working on comments from public hearing in response to the NJDEP Solid Waste Department's Technical Notice of Deficiency letter dated April 11, 2023 (13 points of deficiencies)
 - a. Comments completed and went over format
 - b. Just this morning, sent them to be translated
